
Why are School Taxes Higher in Delano than Surrounding Districts?

Answer: Property Wealth

Imagine you are standing in the checkout line at your favorite convenience store and see that the customer in front of you has the exact same coffee and doughnut as you. You are surprised that the total on the register for his purchase is less than what you usually pay. When the clerk rings up your purchase, the total is twice as much. Baffled, you ask the clerk why your exact same purchase is so much more, he calmly replies, "That is why we ask for your zip code, we have to charge the people from your town twice as much."

As you probably know, property taxes are a very important element in Minnesota's education funding system, but school districts have widely varying levels of property wealth. The Minnesota Consitution calls for a "uniform" system of public education. Yet, in school districts without significant commercial and industrial development to expand the tax base and lower the individual taxpayer cost, the burden for school levies falls heavily on the local home and small business owners in mostly residential school districts like Delano. This DOES NOT provide a "uniform" system of public schools. Today, taxpayers in low property wealth districts can pay two to three times more than similar taxpayers in high property wealth districts. This is why the school portion of your tax bill is higher than surrounding districts.

The availability of quality educational services should not be determined by your zip code. All students deserve quality programs and facilities and all property taxpayers need school levies to be equitable and affordable.



This graph illustrates what a taxpayer in each of these school districts would pay on a \$100,000 home. As you can see by the chart, a Delano taxpayer pays \$183 dollars to Westonka's \$65. This graph shows the educational funding inequities that are evident in surrounding districts.

What can you do as a taxpayer in the Delano School District?

The 2017 Legislative Session will address educational funding. Lawmakers in this legislative session must fix this inequity by increasing current equalization funding which will provide immediate property tax relief to taxpayers and will make the education system more equitable statewide.

Schools for Equity in Education (SEE) encourage taxpayers to talk with their local state legislators to ask them to make property tax relief for school levies and bonds a top priority in the upcoming legislative session. Why Does Delano Public Schools have a Director of Teaching & Learning?

In 2001, the Delano Public School district asked voters to approve an operating levy to maintain staffing across the district. Unfortunately, the operating levy did not pass and as a result, one of the reductions made was to reduce the Curriculum Director and the High School Assistant Principal positions to half time. Prior to that, each position was staffed as full time. For the past 14 years, we have staffed these two previously defined positions with one staff member. During this time, the district has grown by more that 27% from 1877 students to over 2400 students in 2016-2017.

Last spring the Delano School Board approved the reinstatement of both the Assistant High School Principal and the Curriculum Director back to full time positions. Since the Curriculum Director position will be dealing with more than just curriculum, it has been renamed the Director of Teaching and Learning (DTL). As the name suggests, there is a major emphasis placed on how we are teaching and how our students are learning. This position has three



primary responsibilities: overseeing the Professional Development Committee, the District Assessment Coordinator, and the Curriculum Director.

The Professional Development Committee, delegates the resources of time and money. This committee is responsible for establishing budgets for each of the buildings across the district and establishing and approving agendas for each of the four professional development days throughout the school year. This committee has been instrumental in the

The Director of Teaching and Learning provides curriculum guidance, professional development planning, student assessment management, and research insight to assist staff with best practices to maximize student achievement. development and completion of mapping our curriculum district-wide which is part of our 5-Year Strategic Plan. Additionally, there is a Staff Development Report that is required by the Minnesota Department of Education as part of the Annual Report on Accountability. The DTL must compile and submit this report to be accountable for the expenditures of that committee.

As the District Assessment Coordinator (DAC), the Director of Teaching and Learning is responsible for all things related to district-wide testing, particularly the MCA state tests in reading, math and science. Any year-to-year changes from the Minnesota Department of Educa-

tion are related through the DAC's for implementation. Coordinating with the IT department to ensure that our technology can handle the rigors of testing up to 250 students at one time as well as scheduling are critical to a smooth testing experience for all students. Additionally, all testing results are sent to the DTL which then are organized and uploaded into our district student information database. This year, for the first time, teachers were given a list of their individual students with their previous year's test results which helps teachers prepare more personalized learning experiences.

The responsibilities of the Curriculum Director portion of the DTL position is two-fold. First, the DTL facilitates the District Advisory Committee, whose main job is to review curriculum, recommend board approval, and review the district's report on accountability. The District Advisory Committee meets approximately four times per year. At the first meeting, they review the accountability report. At subsequent meetings, one curriculuar area is reviewed at each meeting. Secondly, the Annual Report on Accountability is presented to the District Advisory Committee, and after approved, presented to the school board.

Finally, the Director of Teaching and Learning needs to stay abreast of the latest educational research and keep district staff members informed of this research. There has been a multitude of research in the last two decades which has given teachers a clear idea of what works best with students and how to maximize achievement in and out of the class-room. Regular classroom visits are also critical in maintaining strong relationships with staff, while watching student-teacher engagement.
